

# Enbridge Gas Inc.

## Notice of Upcoming Study Commencement and Information Session

### Mississauga Reinforcement Project

Enbridge Gas Inc. (Enbridge Gas) is proposing to construct new pipeline infrastructure in the City of Mississauga and Town of Oakville. The purpose of the project is to accommodate, in part, a transition from other fuel sources to natural gas for existing Enbridge Gas customers. The project includes the construction of natural gas pipeline in the City of Mississauga and Town of Oakville, as well as the rebuilding of some existing natural gas customer stations located on the customers' properties. These customers have been previously notified. There are three pipeline route options being evaluated; depending on the route chosen, the pipeline would be between 0.35 km and 3.1 km long. The project will tentatively be located in the existing municipal road allowance and on the customers' properties, and may also require permanent easements, temporary working space, and lay-down areas during construction. The proposed locations of the preferred and alternate routes have been developed for the purposes of an assessment of potential environmental and socio-economic impacts and does not represent the final project scope/design. 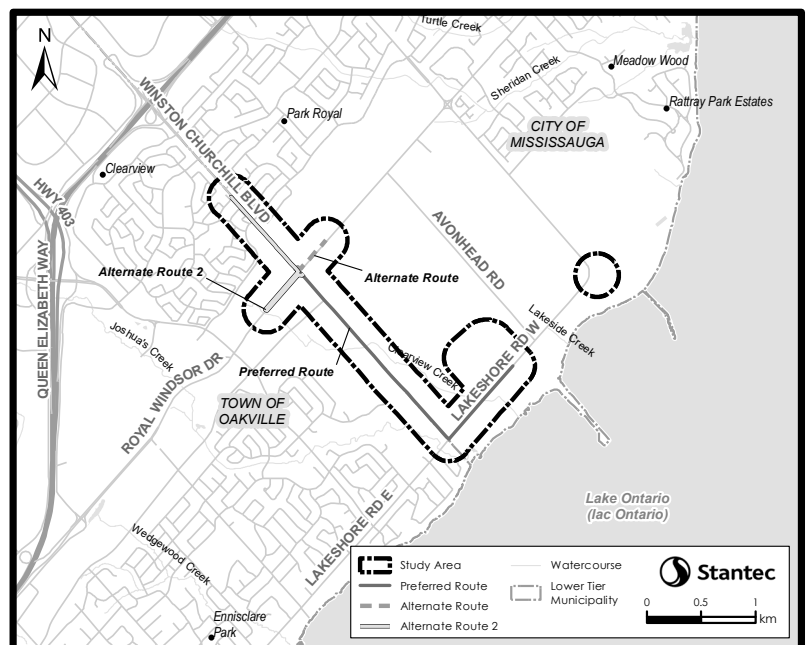
A copy of the Information Session story boards will be available for viewing on the Enbridge Gas project website provided below. A questionnaire will also be available as part of the Information Session, and you will have the opportunity to provide comments and/or questions about the proposed project. Input received during the Information Session will be used to develop site-specific environmental protection and mitigation measures for the project. Input and comments for the project are requested by **August 21, 2024**.

As part of the planning process, Enbridge Gas has retained Stantec Consulting Ltd. to undertake an Environmental Study for the project. The Environmental Study will fulfill the requirements of the Ontario Energy Board's (OEB) "Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Projects and Facilities in Ontario, 8th Edition (2023)". It is anticipated that an Environmental Report for the study will be completed in December 2024, after which Enbridge Gas will file an application to the OEB to request a Leave to Construct for the project. Should the OEB find the project to be in the public's interest, construction is anticipated to commence as early as Q4 2026.
