# Natural gas rates have changed

# New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **July 1, 2024.** 

The total impact on your bill will depend on how much gas you use and the terms of your gas marketer agreement.

### **Delivery to You**

The delivery charges that vary with consumption increased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The delivery charges on your bill include a credit for the clearing of various deferral accounts and a charge for the 2024 rate adjustment as approved by the OEB. Details for these rate adjustments can be found in the rate adjustment section below.

#### **Federal Carbon Charge**

The federal carbon charge is 15.25 cents per cubic metre (¢/m³). This charge increases annually each April. All of the money collected for this charge goes to the government.

#### **Gas Supply Commodity Charge**

The price you pay for the natural gas you use, shown as the gas supply charge on your bill, depends on the terms of your gas marketer agreement.

#### **Rate Adjustments**

The OEB-approved rate adjustment to reflect the changes to Enbridge Gas' 2024 rates to recover the revenue variance between the approved effective date of Jan. 1, 2024 and the implementation date of May 1, 2024, will continue to be applied from May 1, 2024 to Dec. 31, 2024 and will be included in the Delivery to You, Transportation to Enbridge and Gas Supply Commodity sections. The total impact on your bill will depend on your usage.

The OEB-approved rate adjustment to reflect the clearance of various deferral and variance account balances will continue to be applied from May 1, 2024 to Dec. 31, 2024 and will be included in the Delivery to You charge. The total impact on your bill will depend on your usage.

Charges for gas used from July 1, 2024 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate M2 - Union South customer who uses 73,000 cubic metres (m³) per year while buying gas from an energy marketer.
