Natural gas rates have changed

New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **April 1, 2025**.

A typical commercial and industrial customer will see an annual decrease of 21.4 percent. The total impact on your bill will depend on how much gas you use.

Delivery to You

The delivery charges that vary with consumption increased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The facility carbon charge has increased from 0.0143 cents per cubic metre (¢/m³) to 0.0172 ¢/m³. The delivery charges on your bill include a charge for the 2024 rate adjustment as approved by the OEB. Details for these rate adjustments can be found in the rate adjustment section below.

Transportation to Enbridge

The transportation charge has increased by approximately \$20.55 per year for a typical customer due to costs for transporting natural gas to Ontario. The transportation charge includes a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

Federal Carbon Charge

The federal carbon charge is being removed from customer bills effective April 1, 2025. Please note that your bill will continue to show federal carbon charges incurred for any gas usage up to and including March 31, 2025.

Gas Supply Commodity Charge

The gas supply commodity charge has increased from 14.8963 ¢/m³ to 20.1689 ¢/m³ based on our forecast of natural gas market prices for the next 12 months. The gas supply commodity charge includes a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

Cost Adjustment

The current adjustment is a charge of 0.4820 ¢/m³. The cost adjustment reflects the true-up between actual and forecast prices for prior periods. Please see the included chart for the breakdown by component.

Rate Adjustments

The OEB has approved a rate adjustment to reflect the clearance of 2023 federal carbon deferral and variance account balances. This will appear as a one-time adjustment on customers' April bills, and for a typical customer this will be a charge of approximately \$5.17.

The OEB-approved rate adjustment to reflect changes to Enbridge Gas' 2024 rates to recover the revenue variance between the approved effective date of Jan. 1, 2024 and the implementation date of Jan. 1, 2025, will continue to be applied from Jan. 1, 2025 to Dec. 31, 2025 and will be included in the Delivery to You, Transportation to Enbridge and Gas Supply Commodity sections. The total impact on your bill will depend on your usage.

Charges for gas used from April 1, 2025 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate 10 - Union North East customer who uses 93,000 cubic metres (m³) per year.
