

January 2025 **Natural gas rates have changed**

Rate 10 Union North East



New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **Jan. 1, 2025.**

A typical commercial and industrial customer will see an annual increase of 8.9 percent. The total impact on your bill will depend on how much gas you use.

Customer Charge

The customer charge increased to \$82.52 a month to partially recover some of the fixed costs associated with maintaining a safe and reliable natural gas distribution system.

Delivery to You

The delivery charges that vary with consumption increased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The delivery charges on your bill include a charge for the 2024 rate adjustment as approved by the OEB. Details for these rate adjustments can be found in the rate adjustment section below.

Transportation to Enbridge

The transportation charge has decreased by approximately \$65.56 per year for a typical customer due to changes to Enbridge Gas' 2025 rates. The transportation charge includes a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

Federal Carbon Charge

The federal carbon charge is 15.25 cents per cubic metre (¢/m³). This charge increases annually each April. All of the money collected for this charge goes to the government.

Gas Supply Commodity Charge

The gas supply commodity charge has increased from 13.6884 ¢/m³ to 14.8963 ¢/m³ based on our forecast of natural gas market prices for the next 12 months and changes to Enbridge Gas' 2025 rates. The gas supply commodity charge includes a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

Cost Adjustment

The current adjustment is a charge of 0.8484 ¢/m³. The cost adjustment reflects the true-up between actual and forecast prices for prior periods. Please see the included chart for the breakdown by component.

Rate Adjustments

The OEB has approved a rate adjustment to reflect changes to Enbridge Gas' 2024 rates for the period of Jan. 1, 2024 to Dec. 1, 2024. These rates will be applied to customers' bills from Jan. 1, 2025 to Dec. 31, 2025. For a typical customer, this will result in a charge of approximately \$25.48 that will be included in the Delivery to You, Transportation to Enbridge and Gas Supply sections. The total impact on your bill will depend on your usage.

Charges for gas used from Jan. 1, 2025 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate 10 - Union North East customer who uses 93,000 cubic metres (m³) per year.

The total effective gas supply charge has increased since the last rate change.
