Natural gas rates have changed

New natural gas rates

The Ontario Energy Board (OEB) has approved changes to the rates Enbridge Gas charges its customers effective **Oct. 1, 2024**.

A typical commercial and industrial customer will see an annual decrease of 3.4 percent. The total impact on your bill will depend on how much gas you use.

Delivery to You

The delivery charges that vary with consumption decreased based on our forecast cost of delivering natural gas to your home or business. These charges also include a facility carbon charge associated with the operation of Enbridge Gas' facilities to deliver natural gas to you. The delivery charges on your bill include a credit for the clearing of various deferral accounts and a charge for the 2024 rate adjustment as approved by the OEB. Details for these rate adjustments can be found in the rate adjustment section below.

Transportation to Enbridge

The transportation charge has decreased by approximately \$14.50 per year for a typical customer due to lower costs for transporting natural gas to Ontario. The transportation charge includes a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

Federal Carbon Charge

The federal carbon charge is 15.25 cents per cubic metre (¢/m³). This charge increases annually each April. All of the money collected for this charge goes to the government.

Gas Supply Commodity Charge

The gas supply commodity charge has decreased from 10.9951 ¢/m³ to 9.9358 ¢/m³ based on our forecast of natural gas market prices for the next 12 months. The gas supply commodity charge includes a charge for the 2024 rate adjustment as approved by the OEB. Details for this rate adjustment can be found in the rate adjustment section below.

Cost Adjustment

The current adjustment is a refund of 4.1895 ¢/m³. The cost adjustment reflects the true-up between actual and forecast prices for prior periods. Please see the included chart for the breakdown by component.

Rate Adjustments

The OEB has approved a rate adjustment to reflect the difference between the amount customers paid for the energy conservation program (DSM) from Jan. 1 to Dec. 31, 2021 and the actual costs incurred. On October bills, this will appear as a one-time refund of approximately \$585.34 for a typical customer.

The OEB-approved rate adjustment to reflect the changes to Enbridge Gas' 2024 rates to recover the revenue variance between the approved effective date of Jan. 1, 2024 and the implementation date of May 1, 2024, will continue to be applied from May 1, 2024 to Dec. 31, 2024 and will be included in the Delivery to You, Transportation to Enbridge and Gas Supply Commodity sections. The total impact on your bill will depend on your usage.

The OEB-approved rate adjustment to reflect the clearance of various deferral and variance account balances will continue to be applied from May 1, 2024 to Dec. 31, 2024 and will be included in the Delivery to You charge. The total impact on your bill will depend on your usage.

Charges for gas used from Oct. 1, 2024 will be calculated using the new approved rates as shown in the chart. The annualized impact is based on a typical Rate 10 - Union North West customer who uses 93,000 cubic metres (m³) per year.
